Bruce L. Crary, who was a resident of Westport, New York, left a legacy which continues to benefit young people from the Adirondack area. He directed that his estate assist with the college expenses of “deserving students in need of financial assistance.”

The Bruce L. Crary Foundation, a not-for-profit corporation, was established in 1973. The Foundation provides scholarships through the Crary Education Fund to full-time undergraduate students who are residents of Clinton, Essex, Franklin, Hamilton, and Warren counties of northern New York.

To date the Foundation has distributed more than \$10,800,000 in grants to over 6,800 Adirondack students. We are currently assisting over 300 students annually.

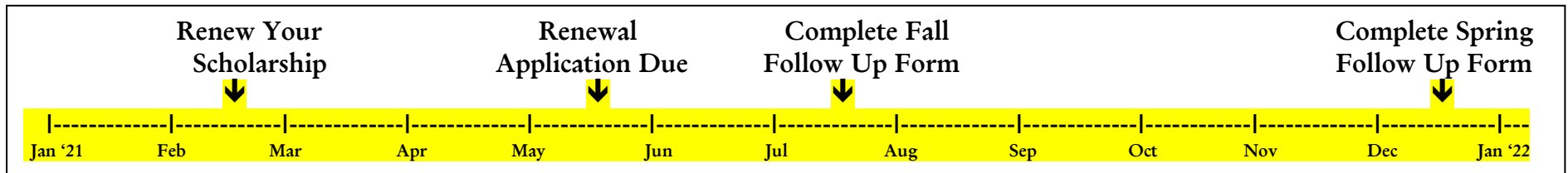

# CRARY SCHOLARSHIP AWARDS

- Scholarships are for full-time study and will be paid in Fall and Spring semester installments.
- Checks will be issued to you personally, not to your college. **Checks will be mailed to your home address.**
- It has been our experience that most colleges will reduce aid or student loan eligibility when outside scholarships are reported to them. Our awards are made after all other financial aid is in place and the student still shows substantial financial need. Our intent is to supplement, not replace, other financial aid.
  - Scholarship funds may be used for tuition, room, board, books, supplies, travel and other expenses related to your undergraduate college attendance.
    - You may re-apply every year for your undergraduate study.

## TIMELINE



**February 15** – a reminder to complete your Renewal Application will be emailed.

The due date is **May 10**

**July 18** – a reminder for the Fall Follow Up Form will be emailed. Complete the form, and upload a copy of your grades. *(Grades are not required for college freshmen.)*

**August 1** – After we receive your Fall Follow Up Form, the Fall Semester check will be mailed to you.

**December 18** – a reminder for the Spring Follow Up Form will be emailed.

**January 2** – After we receive your Spring Follow Up Form, the Spring Semester check will be mailed to you.

**All notifications will be sent to your email address.
